

Plan Ahead Video Competition Rules

1. Eligibility:

- This Competition is open to anyone
- You must be a resident of the Republic of Ireland or Northern Ireland
- Employees of AIIHPC, their relatives and the working group involved with the competition are **not eligible** to enter
- The length of the video content should last up to one minute (60 seconds).
- All entries can be recorded on smart phones, tablets or digital cameras etc and must be submitted in MP4 or WMV format
- Each entry must be submitted with a completed:
 - *'Lead Producer permission for use of video form'*
 - *'Video participant permission for use of video form'* completed by each person featured within the film (if different to the Lead Producer)
 - *'Parent or guardian permission for use of video form'* if the video includes a child under the age of 18. A separate form should be completed for each child

2. Agreement to Rules:

By participating, the Contestant ("You") agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, you agree to accept the decisions of AIIHPC as final and binding as it relates to the content of this Competition.

3. Competition Period:

Entries will be accepted starting at 12pm 13/09/2017 and ending 12pm 5/01/2017.

4. How to Enter:

Entries should be submitted to Dr Cathy Payne cpayne@aiihpc.org using WeTransfer, DropBox, Google Drive or another suitable service. If required, contact Dr Cathy Payne for further guidance cpayne@aiihpc.org

The entry must fulfil all Competition requirements, as specified, to be eligible to be entered for the prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of AIIHPC.

Entrants may work in groups or submit entries as individuals. You can submit as many entries as you wish, but your Lead Producer will only be entered into the draw once. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of AIIHPC.

5. Prize:

The Winner of the Competition will receive a Ticket Master voucher. The value of this voucher is £200. No cash or other prize substitution shall be permitted except at AIIHPC'S discretion. If the winner is unable to receive the prize it may be transferred to a friend or family member. Any and all prize-related expenses shall be the sole responsibility of Winner. Acceptance of prize constitutes permission for AIIHPC to use the winner's name to announce who won the prize.

6. Odds:

The odds of winning depend on the number of eligible entries received.

7. Winner Selection and Notification:

The winner will be selected randomly by computer and under the supervision of AIIHPC. The winner will be notified by email within one week of the competition closing.

If the winner cannot be contacted, is ineligible, fails to claim the prize within 30 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate winner selected. Receipt by the winner of the prize offered in this competition is conditioned upon compliance with any and all state and local laws and regulations.

ANY VIOLATION OF THESE OFFICIAL RULES BY WINNER (at AIIHPC sole discretion) WILL RESULT IN WINNER'S DISQUALIFICATION AS WINNER OF THE COMPETITION, AND ALL PRIVILEGES AS WINNER WILL BE IMMEDIATELY TERMINATED.

8. Rights Granted by You: By entering this content (e.g., photo, video, text, etc.), You understand and agree that AIIHPC, anyone acting on behalf of AIIHPC, and AIIHPC licensees, successors, and assigns, shall have the right, where permitted by law, to print, publish, broadcast, distribute, and use in any media now known or hereafter developed, in perpetuity and throughout the World, without limitation, your entry, name, portrait, picture, voice, likeness, image, statements about the competition, and biographical information for news, publicity, information, trade, advertising, public relations, and promotional purposes without any further compensation, notice, review, or consent.

By entering this content, you represent and warrant that your entry is an original work of authorship, and does not violate any third party's proprietary or intellectual property rights. If your entry infringes upon the intellectual property right of another, You will be disqualified at the sole discretion of AIIHPC. If the content of your entry is claimed to constitute infringement of any proprietary or intellectual proprietary rights of any third party, You shall, at your sole expense, defend or settle against such claims. You shall indemnify, defend, and hold harmless AIIHPC from and against any suit, proceeding, claims, liability, loss, damage, costs or expense, which AIIHPC may incur, suffer, or be

required to pay arising out of such infringement or suspected infringement of any third party's right.

9. Terms & Conditions: AllHPC reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the competition should a virus, bug, non-authorized human intervention, fraud, or other cause beyond AllHPC control corrupt or affect the administration, security, fairness, or proper conduct of the competition. In such case, AllHPC may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by AllHPC.

AllHPC reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the competition or website or violates these Terms & Conditions. AllHPC has the right, in its sole discretion, to maintain the integrity of the competition, to void votes for any reason, including, but not limited to any attempt by an entrant to deliberately damage any website or undermine the legitimate operation of the competition. Should such attempt be made, AllHPC reserves the right to seek damages to the fullest extent permitted by law.

AllHPC reserves the right, in its sole discretion, to disqualify any individual who submits abusive and/or inflammatory content.

10. Limitation of Liability: By entering, You agree to release and hold harmless AllHPC and its subsidiaries, affiliates, advertising and promotion agencies, partners, representatives, agents, successors, assigns, employees, officers, and directors from any liability, illness, injury, death, loss, litigation, claim, or damage that may occur, directly or indirectly, whether caused by negligence or not, from: (i) such entrant's participation in the competition and/or his/her acceptance, possession, use, or misuse of any prize or any portion thereof; (ii) technical failures of any kind, including but not limited to the malfunction of any computer, cable, network, hardware, or software, or other mechanical equipment; (iii) the unavailability or inaccessibility of any transmissions, telephone, or Internet service; (iv) unauthorized human intervention in any part of the entry process or the Promotion; (v) electronic or human error in the administration of the Promotion or the processing of entries.

11. Disputes: THIS Competition IS GOVERNED BY THE LAWS OF THE REPUBLIC OF IRELAND WITHOUT RESPECT TO CONFLICT OF LAW DOCTRINES. As a condition of participating in this Competition participant agrees that any and all disputes that cannot be resolved between the parties, and causes of action arising out of or connected with this Competition, shall be resolved individually, without resort to any form of class action, exclusively before a court located in the Irish jurisdiction. Further, in any such dispute, under no circumstances shall participant be permitted to obtain awards for, and hereby

waives all rights to, punitive, incidental, or consequential damages, including reasonable attorney's fees, other than participant's actual out-of-pocket expenses (i.e. costs associated with entering this Competition). Participant further waives all rights to have damages multiplied or increased.

12. Privacy Policy: Information submitted with an entry is subject to the Privacy Policy stated on AIHPC's website.
